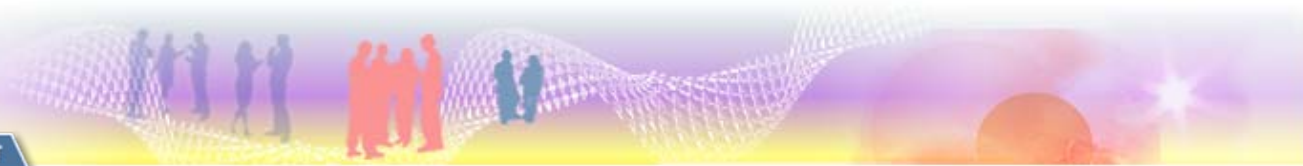

- An **EU inter-parliamentary network** of correspondents to exchange information on *legislation and policies*
- A comprehensive website to support this exchange of information (www.ipex.eu)
- A reference site for parliaments to publish and share their results of EU related parliamentary scrutiny, as well as on issues related to subsidiarity



Why IPEX:

- Cope with the growing relevance of EU information exchange among parliaments
- Facilitate and improve exchange of parliamentary scrutiny, especially in national parliaments
- Increase transparency of EU decision making

Welcome to IPEX



Exchanging EU information among parliaments has become increasingly important during the past decade. In order to facilitate the flow of information, national parliaments - in cooperation with the European Parliament - have created their own database and website - www.ipex.eu.

The **IPEX Database** contains a complete catalog of Commission documents from 2006. From each Commission document users can click on "Related dossiers" and from there access national scrutiny pages. Each national scrutiny page contains documents from the individual national parliaments relating to the specific Commission document or legislative procedure.

IPEX also hosts a **calendar of interparliamentary cooperation** which contains information concerning all interparliamentary meetings relating to the European Union.

Using IPEX

Features

Database

At the core of the IPEX website is the IPEX database. In order to find information from the national parliaments concerning specific EU documents or legislative proposals, users will first have to consult a specific Commission document or legislative dossier (Legislative dossiers are comprised of Commission documents. When consulting a Commission document users will find a link to the related legislative dossier, while legislative dossiers always refer back to the Commission documents that they relate to).

Ec Documents: There are two ways to find Commission documents (COM documents). Users can either click on a chronological list of the latest documents uploaded to IPEX or search for them using the document reference when this is already known.

Dossiers: Users can find dossiers in the same way, either by clicking on a chronological list of the latest dossiers uploaded to IPEX or by searching for them using one of the following codes: COD, CNS, SYN, ACC, AVC, CNB, CNC or just using if the COM reference if the dossier is not part of a legislative procedure.

Documents and dossiers can also be found by making a free text search (the search box is located in the upper right hand side of the website).

An **advanced search** is also available. It allows users to find documents and dossiers by searching by (among other things) title and subject. In addition the advanced search allows users to search for national scrutiny updates by subsidiarity issues and important information to exchange.

Recent scrutiny: The latest scrutiny updates by the national parliaments can always be accessed through a chronological list.
